All premium and standard tables should include \$200/ table deposit to insure reservation.

All economy tables should include \$100/table deposit to insure reservation.

**CONDITIONS**

**Standard Booth**- 8' skirted front & 6' backup table. **Standard Corner Booth**- one 8' and another 8' skirted table placed perpendicular to one another at an aisle end and one 6' backup table.

**Premium**- are versions of each type of booth in a preferred position of maximum traffic flow. **Economy**- are versions of each type of booth located in a less preferred location. All booths have one name sign, night cover (s), two front and two back chairs per front table, a waste receptacle, one electrical outlet, and a table cover.

**Badges**- 2 included in booth price for standard, economy, and economy corner booths. 4 included in booth price for standard corner and premium corner booths. 1 included per day in price of daily booth. Extra badges are available at \$45 each.

1. More than 50% of the material offered shall consist of numismatic material. A written exception may be made for jewelry.
2. Applicants for bourse space must be at least 21 years of age and have a valid Texas Sales Tax number.
3. The bourse booth assigned and the space contained therein cannot be sold, rented, loaned, leased or subleased without the written consent of the Bourse Chairman.
4. Applicant agrees to maintain the booth in the arranged configuration as supplied by The Houston Money Show and will not use supplemental tables not supplied by the Show. Exception may be made with agreement of the Bourse Chairman.
5. Each applicant may share their booth(s) with one (1) additional independent dealer. The applicant assumes all responsibility, financial or otherwise, for all transactions conducted by such independent dealer and any/or other persons in their booth and recognizes by signing this application that others have the right to rely on this representation.
6. Only individuals listed on the Bourse Application or otherwise officially accredited to the assigned booth and wearing booth holder badges shall be permitted behind booth tables.
7. Booth holder badges are not transferable and shall not be loaned or given to others. Violation of the provisions may result in suspension of bourse privileges.
8. Any participant in this show who offers for sale any altered or counterfeit numismatic material may be barred from further participation in the Show and any future shows conducted by the Greater Houston Coin Club, Inc. (GHCC). Replicas, copies, or restrikes must be plainly identified as such, and so advertised to the prospective buyer.
9. The GHCC reserves the right to restrict the sale of material which it deems contrary to the benefit of the Show and its attendees and shall remove such items without recourse.
10. Dealers or their representatives that conduct themselves in a manner deemed detrimental or who violate any provisions of this agreement will be subject to expulsion from the Show, without recourse.
11. No display or sign may be placed or hung in such a position as to block clear view across the bourse area. Signs projecting more than 18 inches above the height of the booth tables and not supplied by GHCC are prohibited, except along perimeter walls.
12. Security is provided for the convenience of the dealers and attendees. The GHCC, the Lone Star Convention Center (LSCC), and **The Houston Money Show**, will not be responsible for any loses, theft or damage, which occurs before, during or after the dealer's participation in the Show. No insurance will be carried for the Show by GHCC, its officers or members, their families and staffs, or by LSCC against any loss of property by or injury to any applicant dealer or any of their agents or employees.
13. **Applications may be cancelled in writing, and payment will be refunded at any time prior to November 1<sup>st</sup>. Cancellations after October 1<sup>st</sup> will forfeit the per booth deposit. Cancellations after December 1<sup>st</sup> will forfeit all payments whether the booth(s) is resold or not. Equipment rental fees are non-refundable after October 1<sup>st</sup>.**
14. Booths not claimed by 9am on Friday may be reassigned without notice or refund to the booth holder.
15. Firearms, pets, radios and/or TV's are not permitted in the bourse area. GHCC reserves the right to prohibit any items which it deems inappropriate from the bourse area.
16. The bourse area is a non-smoking facility. Smoking will only be allowed outside the LSCC facility.
17. Admittance to the bourse area will be 8 am on Friday and Saturday.
18. Receipt of this application and deposit does not constitute acceptance. All applicants will be notified. Signatures of the applicant, dealer hereto, and acceptance hereof by the General or Bourse Chairman, constitutes the contract within the terms and conditions stated herein.

The undersigned applicant in applying for bourse booth or booths and the space contained therein, and if accepted, agrees to the above conditions and hereby releases the Greater Houston Coin Club, Inc., its officers, members, volunteers, **The Houston Money Show**, LSCC, and management and agents from any liability for loss, damage, or destruction (through negligence, gross negligence, or otherwise) of numismatic or any other material and for personal injury and property damage of any kind. The foregoing shall not, however, limit the liability of any individual who may personally be guilty of theft, willful damage, or destruction.
