## **CONDITIONS**

- 1. More than 50% of the material offered shall consist of numismatic material.
- 2. Applicants for bourse space must be at least 21 years old.
- 3. The bourse booth assigned and the space contained therein cannot be sold, rented, loaned, leased or subleased.
- Applicant agrees to maintain the booth in the arranged configuration as supplied by The Houston Money Show and will not use supplemental tables not supplied by the Show.
- 5. Each applicant may share his booth(s) with one (1) additional independent dealer. The applicant assumes all responsibility, financial or otherwise, for all transactions conducted by such independent dealer and any/or other persons in his/her booth and recognizes by signing this application that others have the right to rely on this representation.
- 6. Only individuals listed on the Bourse Application or otherwise officially accredited to the assigned booth and wearing booth holder badges shall be permitted behind booth tables.
- 7. Booth holder badges are not transferable and shall not be loaned or given to others. Violation of this provision may result in suspension of bourse privileges.
- 8. Any participant in this Show who offers for sale any altered or counterfeit numismatic material may be barred from further participation in the Show and any future shows conducted by the Greater Houston Coin Club, Inc. (GHCC). Replicas, copies, or re-strikes must be plainly identified as such, and so advertised to the prospective buyer.
- 9. The GHCC reserves the right to restrict the sale of material which it deems contrary to the benefit of the Show and its attendees and shall remove such items without recourse.
- 10. Dealers or their representatives that conduct themselves in a manner deemed detrimental or who violate any provisions of this agreement will be subject to expulsion from the Show, without recourse.
- 11. No display or sign may be placed or hung in such a position as to block clear view across the bourse area. Signs projecting more than 18 inches above the height of the booth tables and not supplied by GHCC are prohibited, except along perimeter walls.
- 12. Security is provided for the convenience of the dealers and attendees. The GHCC, the Lone Star Convention Center (LSCC), and The

**Houston Money Show** will not be responsible for any losses, theft, or damage which occurs before, during, or after the dealer participation in the Show. No insurance will be carried for the Show by GHCC, its officers or members, their families and staffs, or by LSCC against any loss of property by or injury to any applicant dealer or any of their agents or employees. - 16. The bourse area is a no smoking and no alcohol facility.
- 17. Admittance to the bourse area will be 2pm until 6pm on Thursday and one hour prior to opening to the public on Friday and Saturday for dealers and early bird badge holders.
- 18. Receipt of this application and deposit does not constitute acceptance. All applicants will be notified. Signatures of the Applicant Dealer hereto, and acceptance hereof by the General or Bourse Chairman, constitutes the contract within the terms and conditions stated herein.
- 19. We reserve the right to move an economy booth prior to the start of the show, and we also reserve the right to move economy booths to the front of the bourse if spaces become available Friday or Saturday.
- 20. All exceptions to any of the above conditions are at the discretion of the bourse chair.
